Whole Foods Update

Whole Foods has postponed most of their new store and remodeling projects all across America. One such postponed project is the Whole Foods going in on Blossom Hill. The City expects to see revised plans for the store soon so the construction can be completed for the 2010 projected opening. It is expected that the revised plans will feature a downsized store plan, as Whole Foods has experienced financial set backs due to the current economic climate. The Whole Foods on Blossom Hill is on the priority list for new stores opening in 2010 so as of now there is no reason to expect the opening will be delayed further than 2010.

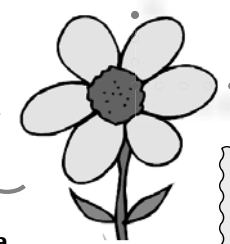

Letter from City Councilmember Kalra

Hello Santa Teresa neighbors! I look forward to seeing you at the general membership meeting on April 30th and updating you on issues important to the community. In the meantime, I did want to update you on a couple of projects happening around the district.

The Hitachi site, which is ultimately planned for close to 3,000 homes and several thousand square feet of commercial space, is currently on hold due to the economic downturn in the housing market. However, the public parks are almost completely finished and will be available for community use within the next few weeks. The parks include a soccer field, baseball diamond and running course. Next to the same site, the Lowe's Home Improvement store is going through the permit process and we can expect to see some physical action on the site before the end of the year.

The police substation on the southeastern corner of the Hitachi site is being built as you read this. However, due to design flaws, there has been a delay that will prevent the opening of the station until well into 2010.

Closer to your neighborhood, the Albertson Parkway is currently being constructed and should be available for use this summer. There were concerns from some neighbors that the trail users could see into their backyards. So, the engineers redesigned the pathways mid-project to lower the trails by about a foot without dramatically slowing down the timeline of the project.

Of course, I am sure you have seen by now the great progress in the construction of the Santa Teresa Library. It is going to be beautiful and you should expect the grand opening late this year.

On another note, budget issues loom large as the economy continues to tank. Due to the recession, the city is getting less revenue from property and sales taxes than we even modestly predicted. Please join me and the Mayor's office on Saturday, May 9th from 10 am to Noon at the Edenvale Library if you would like to learn more about the city budget.

Letter from City Councilmember Pyle

Spring is upon us and that means one thing at City Hall—it is time to talk budget. Due to declining sales tax revenues, lower than anticipated property tax revenues and structural budget problems, San Jose must balance an estimated \$75 million dollar deficit this year alone. The City is streamlining operations to deliver services more efficiently but it will not be possible to close the budget gap without increasing revenue and decreasing costs.

Representatives from the Mayor's Office and the City Manager's Office will present information regarding the budget process and proposed balancing strategies at the meeting.

We'll have a BBQ too! Starting at 11:30 to thank our volunteers and to say "Hi!" to all of our neighbors. Stop on by and bring your appetites!

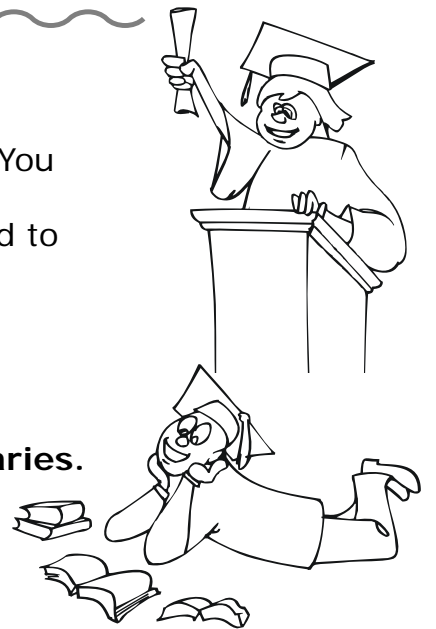


\$1000 Scholarship

Enclosed Event Facility Approved on top of Santa Teresa Hills *Initial plan called for a tent* *STFNA works to reduce impact on neighborhood*

On April 2nd, the Santa Clara County Planning Commission approved the proposed events facility at the Boulder Ridge Golf Course, which is located at the westerly end of the Santa Teresa Foothills. The STFNA Board of Directors supported this decision because, at the request of the Association and other groups in the Almaden Valley, the applicant undertook a major redesign of the project.

The original proposal was an events tent, which the Association opposed because of the noise impacts from amplified music on adjacent neighborhoods. The new design replaces the tent with an enclosed building with fixed/unopenable windows that will contain the noise.

This is a significant win-win wherein our concerns have been addressed and the needs of the applicant have also been met. Thank you for your letters to the County in support of the Association's position, which ultimately led to the new and improved design!
